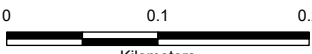

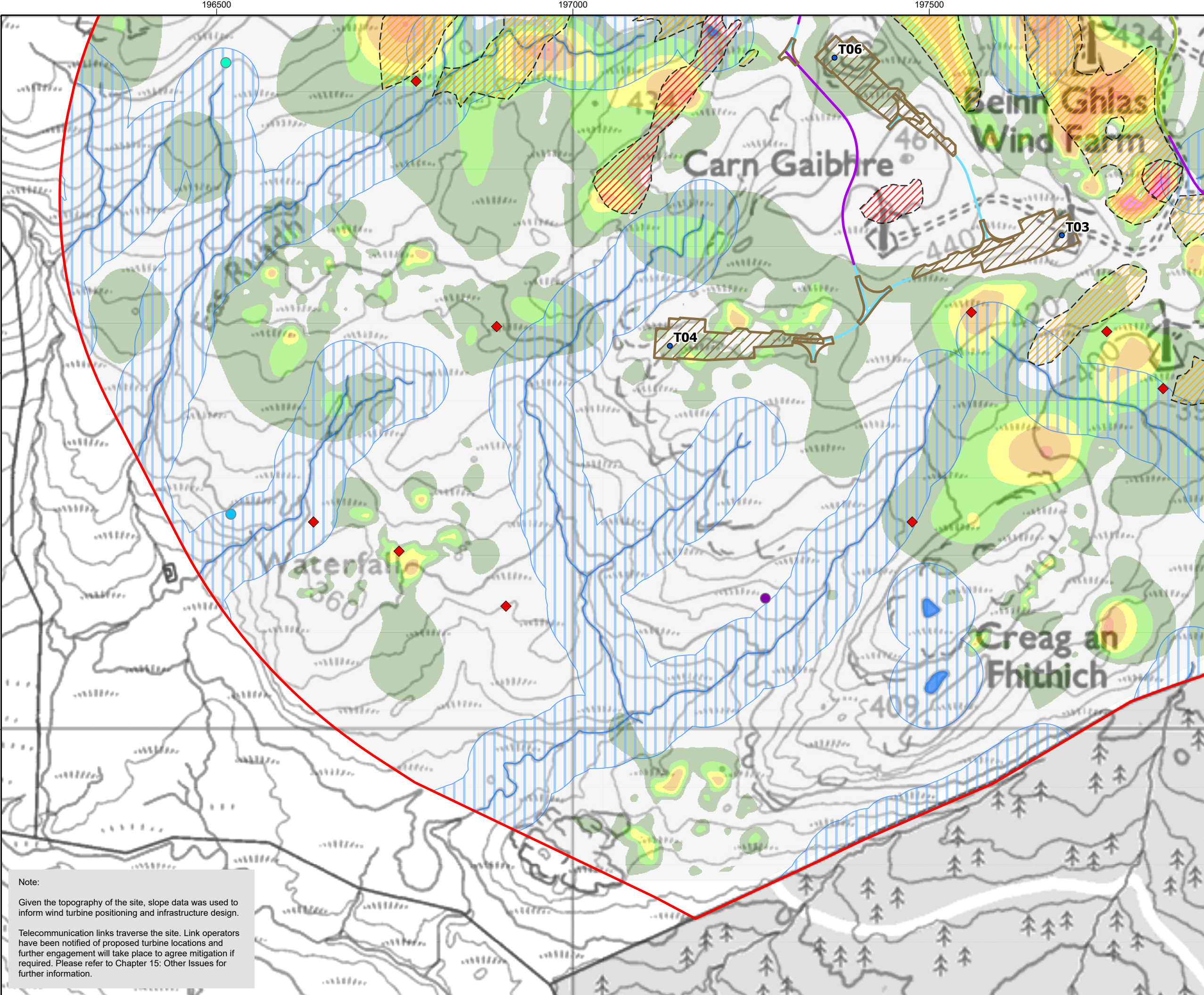

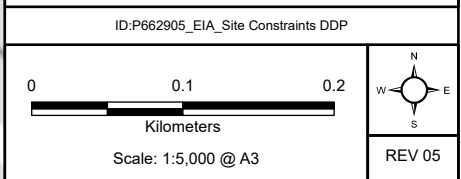

TITLE: Figure 2.2b Onsite Constraints – Site Specific Constraints South-West Quadrant

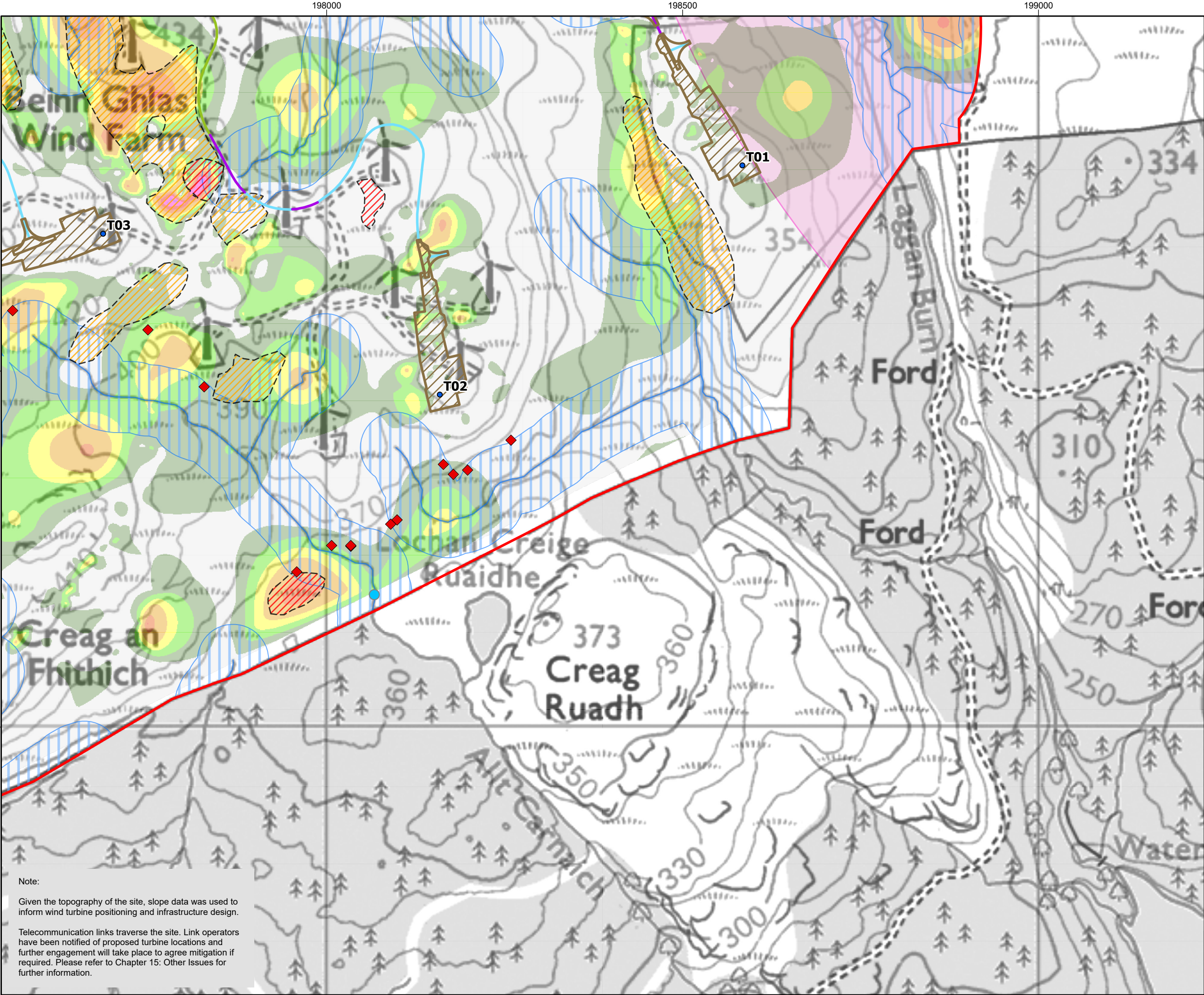

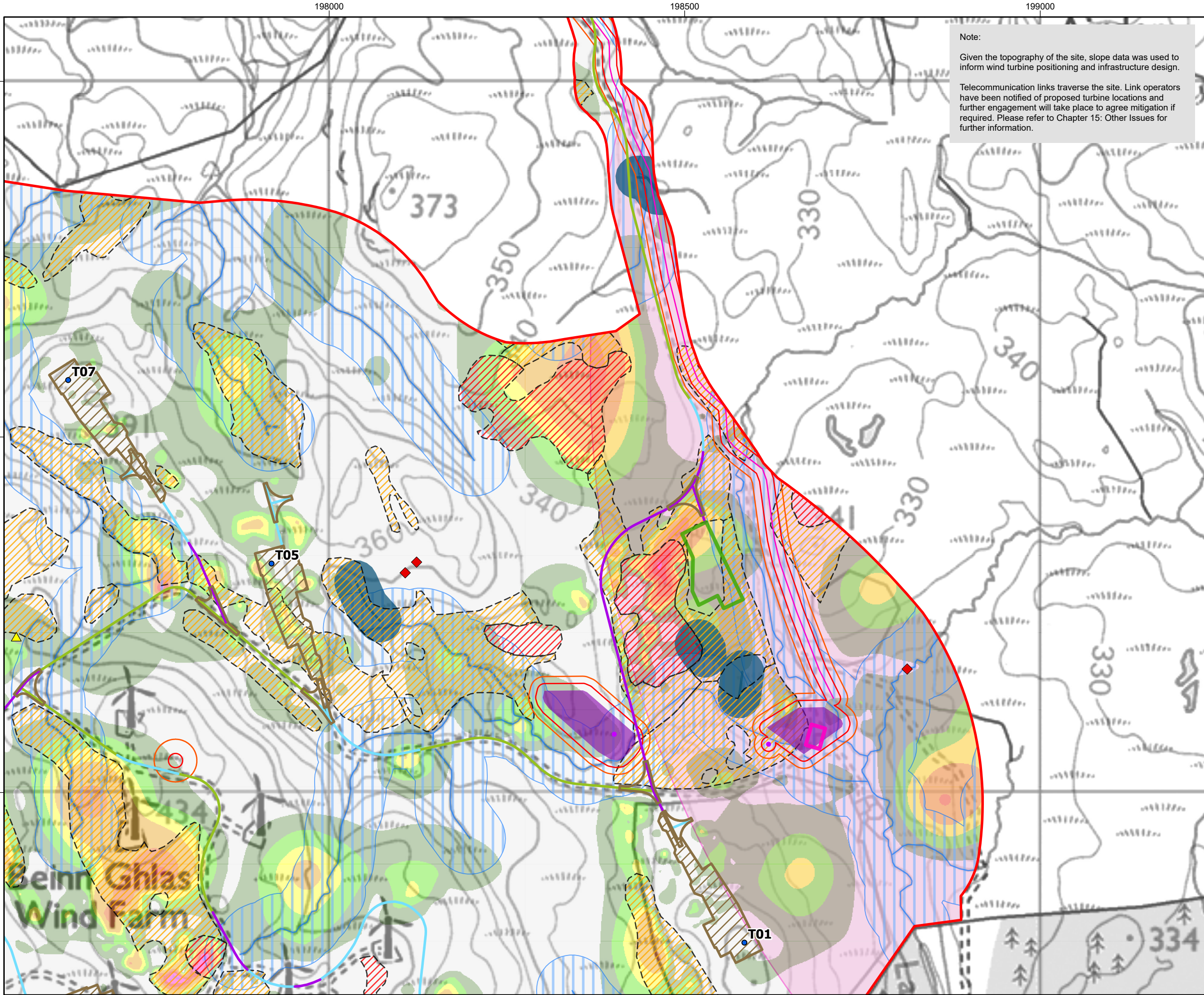

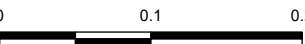
